IMPORTANT NOTICE RE UNSOLICITED CALLS TO MEMBERS

Dear Brothers and Sisters:

This letter concerns the recent mailing of the first unsecured distribution in the above cases, which occurred on June 22, 2007.

We have been advised that someone is making "robo-dialed" calls to members seeking their CF Employee Identification numbers, their Social Security Numbers, or both. These calls do NOT come from our office. We do not know who is making these calls, or why, but whoever they are, they have nothing to do with the distribution, the union, CF or our firm. The calls are not authorized, and there is no reason for the members to speak to these people.

We have also learned that a Portland, Oregon-area law firm is making similar unsolicited calls to your members. That firm also has nothing to do with the CF distribution. Its calls are also unauthorized.

Please advise your members that they should not discuss the distribution and should not give personal information over the phone to strangers.

For your information, the ONLY authorized calls will come from our office (either from the undersigned, or from one of the employees of our firm) and will always originate from one of our lines in the 414 area code. We only call in response to a member's call to our firm on the 414-223-0408 line mentioned in previous correspondence to you (every member included in the distribution has been given this number in a letter to him or her as well).

We ONLY ask for an employee's ID or SSN to verify who they are. The employee knows whether or not he or she called us, and therefore knows whether we are returning a call from him or her, or whether the call is an unsolicited one from a stranger.

Our concern is that a stranger, with the ID or SSN of an employee, might be able to contact our office or CF and redirect the member's check to another location (by, for example, giving a false change of address).

Please take the action you consider appropriate to alert your members not to give personal information over the phone to an unsolicited caller. To reiterate, all authorized calls will originate from our law office, and will be made by an employee or attorney from our firm.

All member calls should be directed to 414-223-0408, never any other number.
